CUSTOMER CONTRACT REQUIREMENTS

- **252.225-7002 Qualifying Country Sources as Subcontractors** (JUN 2012).
- **252.225-7004** Reporting Of Contract Performance Outside The United States And Canada Submission After Award (OCT 2010). "Contracting Officer" means "Buyer." Paragraph (c)(5) is deleted. In (d)(2) "from the Contracting Officer or" is deleted.
- **252.225-7006 QUARTERLY REPORTING OF ACTUAL CONTRACT PERFORMANCE OUTSIDE THE UNITED STATES** (OCT 2010). In subparagraph (b), "within 10 days after" is replaced by "10 days prior to."
