**CUSTOMER CONTRACT REQUIREMENTS**

The following customer contract requirements apply to this contract to the extent indicated below.

**1. DEFCONs** The following contract clauses are incorporated by reference from the United Kingdom (UK) Defence Contract Conditions (DEFCONs) which may be accessed on the UK Ministry of Defence (MOD) web site and apply to the extent indicated. In all of the following clauses, "Contractor" and "Offeror" mean Seller.

**126 International Collaboration** (NOV 2006). This clause applies to contracts for research, study, or development work. The term "Contractor" shall mean "Seller."

**129 Packaging (For Articles Other Than Ammunition and Explosives)** (JUL 2008).

**14 Inventions and Designs** (NOV 2005). This clause applies to contracts for research, design, or development work. The term "Contractor" shall mean "Seller."

- o Confirming the Cost of Minor Obsolescence Issues mitigation and resolution cap (Condition 30)
- o Gainshare and Continuous Improvement (Condition 34)

**656 Break** (MAR 2006). Break. Articles 1 through 5 of this provision applies if this contract is £50,000 or more. The term "Authority" means Buyer except in paragraph 3.a)i. The period of notice shall be that period specified in Buyer's contract with the U.K. Government.

**68 Supply of Data for Hazardous Articles, Materials and Substances** (MAY 2011). "Authority" shall mean Buyer except in the last sentence of paragraph 1, where it means Authority and Buyer.
