- (1) Seller shall comply with all applicable Federal, State and local environmental statutes and regulations for all activities defined in this SOW. The Seller shall use National Aerospace Standard (NAS) 411 as a guide for implementing a Hazardous Material Management Program (HMMP).
- (2) The use of toxic chemicals, hazardous substances shall be avoided or minimized in the operation, repair and maintenance of the equipment and its components, whenever feasible. Seller and its subcontractors shall not use Class I and should avoid or minimize the use of Class II Ozone Depleting Substances (ODSs).
- (3) Seller shall report hazardous materials (HAZMATS) which travel with the weapon system, parts, or other deliverables to the Government with special emphasis on the Environmental Protection Agency (EPA) list of 17 toxic chemicals as well as the DOD top 10 Toxic Release Inventory (TRI) List of Hazardous Chemicals.

C. CONDUCT OF PERSONNEL

The Seller, including its assigned personnel performing services on a military reservation, shall be guided by and shall observe and comply with all applicable rules and regulations, directives, and requirements pertaining to conduct of personnel on the Military Reservation.
