This agreement does not relieve the Seller of its responsibility to manage the subcontracts effectively and efficiently nor is it intended to establish privity of contract between the Government, Buyer or The Aerospace Corporation and such subcontractors.

E. SUBCONTRACTOR WARRANTIES

In addition to any other warranty rights and remedies by the contract, the Seller shall assure that all subcontractor warranties/guarantees applicable to the accessories, equipment and parts installed in or provided as a part of the (end item) purchased under this contract are fully available to, and for the benefit of the Government for the life time of such warranties and shall enforce these warranties on behalf of the Government consistent with the Contracting Officer or Buyer's direction and the terms of the applicable warranty so long as such warranties shall remain in effect.
