CUSTOMER CONTRACT REQUIREMENTS

 - 252.225-7013 Duty-Free Entry (JUN 2005). This clause applies if this contract is for (i) qualifying country components or (ii) nonqualifying country components for which the U.S. duty is estimated to exceed \$200 per
