CUSTOMER CONTRACT REQUIREMENTS

The following customer contract requirements apply to this contract to the extent indicated below. If this contract is for the procurement of commercial items under a Government prime contract, as defined in FAR Part 2.101, see Section 3 below.

This clause applies only if this contract exceeds \$150,000 and (i) is cost-reimbursement, incentive, time-and-materials, labor-hour, or price-redeterminable type or any combination of these types; (ii) Seller was required to provide cost or pricing data, or (iii) Seller is required to furnish reports as discussed in paragraph (e) of the referenced clause.

52.215-23 Limitations on Pass-Through Charges. (OCT 2009). Delete paragraph (e) and insert the following paragraph (e) in lieu thereof: "Seller shall make the representation required by paragraph (b) of this clause by submitting an updated Buyer Form F70102 or updating Seller's profile information on line in Buyer's BEST system."

52.222-1 Notice to the Government of Labor Disputes (FEB 1997). Contracting Officer shall mean Buyer.

52.222-35 Equal Opportunity for Veterans. (OCT 2015). This clause applies only if this contract is \$150,000 or more.

52.222-36 Equal Opportunity for Workers with Disabilities (JUL 2014). This clause applies only if this contract exceeds \$15,000.

52.222-50 Combating Trafficking in Persons (MAR 2015). The term "Contractor" shall mean "Seller", except the term "prime contractor" shall remain unchanged. The term "Contracting Officer" shall mean "Contracting Officer and the Buyer's Authorized Procurement representative in paragraph (d)(1). Paragraph (d)(2) shall read as follows: "If the allegation may be associated with more than one contract, the Seller shall inform the Buyer's Authorized Procurement Representative for each affected contract." The term "the Government" shall mean "the Government and Buyer" in paragraph (e). The term "termination" shall mean "cancellation" and "Cancellation for Default", respectively, in paragraph (e)(6). The term "Contracting Officer" shall mean "Contracting Officer and Buyer" in paragraph (f), except in paragraph (f)(2), where it shall mean "Contracting Officer or Buyer". Paragraph (h)(2)(ii) shall read as follows: "To the nature and scope of the activities involved in the performance of a Government subcontract, including the number of non-United States citizens expected to be employed and the risk that the contract or subcontract will involve services or supplies susceptible to trafficking in persons." The term "Contracting Officer" shall mean "Contracting Officer or Buyer" in paragraph (h)(4)(ii). The term "Contracting Officer" shall mean "Buyer" in paragraph (h)(5).

 $\textbf{52.227-10 Filing of Patent Applications - Classified Subject Matter} \ (\text{DEC } 2007).$

52.228-5 Insurance - Work on a Government Installation (JAN 1997).

This clause applies to contracts that requires work on a Government installation. In paragraph (b) and (b)2, "Contracting Officer" shall mean "Buyer". In paragraph (c), "Contracting Officer" shall mean "Contracting Officer or Buyer". Seller shall provide and maintain insurance as set forth in this contract, which is ______.

52.230-6 Administration of Cost Accounting Standards (JUN 2010). Add "Buyer and the" before "CFAO" in paragraph (m). This provision applies if clause H001, H002, H004 or H007 is included in this contract.

52.232-39 Unenforceability of Unauthorized Obligations (JUN 2013).

52.244-6 Subcontracts for Commercial Items (DEC 2015). Clauses in paragraph (c) (1) are applicable to Seller for commercial items ordered by Buyer from Seller under this contract.

52.245-1 Government Property (AUG 2010). This clause applies only if Government property is acquired or furnished for contract performance. The Buyer will process VECP's expeditiously; however, it will not be liable for any delay in acting upon a VECP.

Paragraph (m) shall read as follows: (m) Data. The Seller may restrict the Government's right to use any part of a VECP or the supporting data by marking the following legend on the affected parts:

These data, furnished under the Value Engineering clause of contract, shall not be disclosed outside the Buyer and Government or duplicated, used, or disclosed, in whole or in part, for any purpose other than to evaluate a value engineering change proposal submitted under the clause. This restriction does not limit the Buyer's and Government's right to use information contained in these data if it has been obtained or is otherwise available from the Seller or from another source without limitations.

If a VECP is accepted, the Seller hereby grants the Government unlimited rights in the VECP and supporting data, except that, with respect to data qualifying and submitted as limited rights or Government purpose rights technical data, the Government shall have the rights specified in the contract modification implementing the VECP and Seller shall appropriately mark the data. (The terms "unlimited rights" a "limited rights" and "Government purpose rights" are defined in Part 27 of the Federal Acquisition Regulation ("FAR") or Part 227 of the Defense FAR Supplement, as applicable.)

Seller's share of the net acquisition savings and collateral savings shall not reduce the Government's share of concurrent or future savings or collateral savings. Buyer's payments to Seller under this clause are conditioned upon Buyer's receipt of authorization for such payments from the Government

Paragraph (g) is deleted.

252.204-7000 Disclosure of Information (DEC 1991). Seller will submit requests for authorization to release through Buyer. Seller shall submit written requests to Buyer a minimum of 60 days prior to proposed date of release.

252.204-7012 Safeguarding Covered Defense Information and Cyber Incident Reporting (DEC 2015). This clause applies if the Contract is for operationally critical support or where performance will involve a covered contractor information system. The term "contractor" retains its original meaning wherever the word is not capitalized. In the terms "Contractor attributional/proprietary information," "Contractor information system" and "covered contractor information system," the term "contractor" also retains its original meaning. In paragraphs (d) and (g), "Contracting Officer" shall mean "Contracting Officer or Buyer." In paragraph (m)(2), the term "prime Contractor" retains its original meaning. 252.209-7010 Critical Safety Items (AUG 2011). Delete the 2nd sentence in paragraph (b) and substitute the following sentence in lieu thereof: The identification of any designated critical safety items are included elsewhere in this contract. Delete paragraph (c) and insert the following in lieu thereof: Heightened quality assurance surveillance. Critical safety items identified and designated in acordance with paragraph (b) of this clause are subject to heightened, risk-based surveillance by Buyer and/or the Government.

252.211-7000 Acquisition Streamlining (OCT 2010). This clause applies only if this contract exceeds \$1.5 million.

252.211-7003 Item Identification and Valuation (JUN 2011). This clause applies if Buyer has made known to Seller that it is acquiring by this contract any item for which unique item identification is required in accordance with paragraph (c) (1) of this clause.

252.215-7000 Pricing Adjustments (DEC 2012). This clause applies only if this contract exceeds the threshold set forth in FAR 15.403-4.

252.219-7003 Small Business Subcontracting Plan (DoD Contracts) (OCT 2014). Paragraph (e) shall be deleted.

252.223-7001 Hazard Warning Labels (DEC 1991). This clause applies only if Seller delivers hazardous material under this contract.

252.223-7002 Safety Precautions for Ammunition and Explosives (MAY 1994). This clause applies only if this contract involves ammunition or explosives. "Government" means Government or Buyer in paragraph (b)(2), each time it appears in (e), (f)(1), (f)(2), the first time it appears in (g)(1)(i), and in (g)(3). "Government" means Buyer in paragraphs (c)(3), (c)(4), (c)(5), and the second time it appears in (g)(1)(i). "Contracting Officer" means Contracting Officer and Buyer in paragraph (g)(4). "Contracting Officer" means Buyer in paragraphs (c)(1), (c)(2), (c)(3), (c)(4), (c)(5), and each time it appears in (d).

252.223-7003 Change in Place of Performance-Ammunition and Explosives (DEC 1991). This clause applies only if DFARS 252.223-7002 is applicable to this contract. The term "Contracting Officer" means Buyer.

252.223-7006 Prohibition on Storage, Treatment, And Disposal of Toxic Or Hazardous Materials (SEP 2014). This clause applies if the contract requires, may require, or permits Seller access to a DoD installation. Seller shall include this clause in any of their subcontracts.

252.223-7007 Safeguarding Sensitive Conventional Arms, Ammunition, and Explosives (SEP 1999). This clause applies

252.225-7004 Reporting Of Contract Performance Outside The United States And Canada - Submission After Award (OCT 2010). "Contracting Officer" means "Buyer." Paragraph (c)(5) is deleted. In (d)(2) "from the Contracting Officer or" is deleted.

252.225-7006 QUARTERLY REPORTING OF ACTUAL CONTRACT PERFORMANCE OUTSIDE THE UNITED STATES (OCT 2010). This clause applies if this contract exceeds \$650,000, except if this contract is for the sale of commercial items, construction, ores, natural gases, utilities, petroleum products and crudes, timber (logs), or subsistence. With respect to this contract, Seller shall comply with the requirements in paragraphs (b) through (e) of this clause. In subparagraph (b), "within 10 days after" is replaced by "10 days prior to." In subparagraph (d), "Deputy Director of Defense Procurement and Acquisition Policy" means "Buyer." In (e)(2), "from the Contracting Officer" is deleted.

252.225-7007 Prohibition on Acquisition of United States Munitions List Items from Communist Chinese Military Companies (SEP 2006).

252.225-7009 Restriction on Acquisition of Certain Articles Containing Specialty Metals (OCT 2014). Paragraphs (d) and (e) (1) of this clause are excluded. The parties are also allowed to negotiate special license agreements, subject to certain limitations (e.g., see paragraph 2. below).
 - 1. Identification and Assertion of Restrictions. If the Seller (including its subcontractors or suppliers at any tier) desires to provide the Government with less than Unlimited Rights in any technical data or computer software, that technical data and computer software must have been identified using the procedures and format required by special contract requirement H020 Identification and Assertion of Restrictions on Technical Data and Computer Software. The license rights identified in the list(s) for technical data and computer software for the tasks included in paragraph b.1 above, including at least those minimum rights specified for these purposes in paragraph 2.B below.
 - 2. Government's License Rights. Subject to the rights and obligations referenced in paragraph (e) of this clause, the Government shall have the following license rights:
 - A. Pursuant to the contract clauses governing rights in technical data and computer software, the Government is granted Unlimited Rights in all technical data (including computer software documentation) that is necessary for operation, maintenance, installation, or training. However, for such technical data or computer software related to items developed exclusively or partially at private expense, the Government is willing to accept less than Unlimited Rights in such technical data or computer software, as long as the Government obtains rights sufficient for tasks identified in paragraph b.1. No specifically negotiated license shall contain any limitations or restrictions on the Government's ability to perform the tasks identified in paragraph b.1 above. If any specifically negotiated license contains any term or condition purporting to limit or restrict the Government's ability to perform the tasks identified in paragraph b.1 above, this clause shall take precedence and such term or condition in the specifically negotiated license shall have no force or effect.
 - B. If the Seller provides the Government with less than Unlimited Rights in such technical data or computer software related to items developed exclusively or partially at private expense, the Government shall have at least the following rights in all technical data and computer software necessary for depot level maintenance and training system activities:
 - (i) For noncommercial technical data, all rights included in Limited Rights (DFARS 252.227-7013(a)(13)) and all rights specified in b.1; and for commercial technical data, all rights specified at DFARS 252.227-7015(b)(2), all rights specified in b.1, and all additional rights contained in any license customarily provided to the public.
 - (ii) For noncommercial computer software, all rights specified in b.1 and all rights included in Restricted Rights (DFARS 252.227-7014(a)(14)); and for commercial computer software, all rights specified in b.1 and all additional rights contained in any license customarily provided to the public.
 - (iii) In addition to the rights specified in (i) and (ii), and subject to the protections in paragraph c.3., the right to release or disclose all such technical data or computer software outside the Government, and to authorize the recipient of such information to use, modify, release, perform, display, or disclose the technical data or computer software for the sole purpose of performing or supporting the tasks identified in paragraph b.1 above.
 - (iv) Unless authorized in writing by the party asserting restrictions on such technical data or computer software, the Government and its contractors (i.e., as recipients under paragraph (iii) above) may not use such technical data or computer software to manufacture additional quantities of any item or for any commercial purpose.
 - 3. All contractors or other persons receiving technical data or computer software as authorized by

paragraph B above shall be subject to a legal prohibition (e.g., nondisclosure agreement) against using such technical data and computer software for any purpose other than supporting the Government's activities described in paragraph b.1 above, as appropriate and authorized, for the F-15SA weapon system and equipment.

- d. Technical Data and Computer Software of Subcontractors and Suppliers. Seller shall include these requirements in its subcontracts or other contractual or legal instruments with all its subcontractors or suppliers whose data deliverables are affected by this clause. To the extent Seller or its subcontractors intend to deliver any technical data or computer software with less than unlimited rights, Seller shall provide in its proposal a Data Assertions Table in compliance with this clause and the clause set forth herein entitled "Identification and Assertion of Restrictions on Technical Data and Computer Software." Seller shall propose license terms in the Data Assertions Table, for any technical data or computer software for which Seller proposes specially negotiated license terms. (Copies of the Data Assertions Table are available in the Description column for FA8634-12-R-2651 in the index for Customer Contract Requirements.)
- e. Validation of Asserted Restrictions and Restrictive Markings. Nothing in this special contract requirement limits or otherwise affects the parties' rights or obligations specified in DFARS 252.227-7019 or DFARS 252.227-7037.

H002 Modification of Data Requirements (MAY 2011).

During the performance of this contract, Buyer's customer may, through Buyer, require minor changes to the SDRLs that are expected to have no impact on the established contract prices and value. These changes include such things as change in place of delivery and other administrative and clarification changes to the SDRLs. Seller will be informed of these changes by issuance of a purchase contract change (PCC) that will reference this clause as its authority. Within 10 days of receipt of the PCC, Seller will notify the Buyer's Authorized Procurement Representative in writing either -

- (1) that it shall proceed with the changes at no change in the price(s) of the contract, or
- (2) that there is an impact on the contract price(s). For those changes described under this paragraph, Seller shall, at Buyer's direction, submit a contract change proposal and shall not proceed with any of the changes described in the PCC until authorization from Buyer's Authorized Procurement Representative. For those changes described in paragraph (1) above, Seller shall proceed with the change(s) described in, and under the authority of, the PCC. Once a year, the SDRL changes that have been directed in this manner and are accomplished at no change in contract price(s), will be formally incorporated into a no change in price, unilateral contract modification.

H020 Identification and Assertion of Restrictions on Technical Data and Computer Software (MAY 2011).

- (a) Definitions. Terms used in this special contract requirement (SCR) that are defined in the following clauses and SCR have the same meaning as set forth in those clauses and SCR:
 - (1) DFARS 252.227-7013;
 - (2) DFARS 252.227-7014;
 - (3) DFARS 252.227-7015;
 - (4) DFARS 252.227-7017; or
 - (5) H001, Delivery and License Rights for Technical Data and Computer Software (FEB 2012).
- (b) Identification and Assertion of Restrictions. Seller shall not deliver under this contract any technical data or computer software with restrictive markings (or otherwise subject to restrictions on access, use, modification, reproduction, release, performance, display, or disclosure) unless the technical data or computer software has been identified in accordance with the following requirements:
 - (1) In the Data Assertions Table in the contract, Seller (including its subcontractors or suppliers, or potential subcontractors or suppliers, at any tier) identified all technical data and computer software that it proposed to be delivered with less than Unlimited Rights as follows:
 - (i) Noncommercial Technologies. Noncommercial technical data and noncommercial computer software was identified pursuant to DFARS 252.227-7017.
 - (ii) Commercial Technologies. Seller also identified and asserted any restrictions for all commercial computer software and commercial technical data (i.e., technical data pertaining to a commercial item) by providing the same types of information, using a similar format, and following the same procedures and requirements as specified at DFARS 252.227-7017.
 - (iii) The requirement to submit, complete, and sign the identification and assertions required

by paragraphs (b)(1)(i) or (b)(1)(ii) of this clause was considered a material element of the final negotiated agreement (including, but not limited to, the final agreed to terms and conditions and contract price) and failure to meet this requirement could have rendered the offer ineligible for award.

- (2) Post-Award Updates to the Pre-Award Identification and Assertions. Except as provided in this paragraph, Seller (including its subcontractors or suppliers at any tier) shall not supplement or revise the pre-award Data Assertions Table after contract award.
 - (i) Noncommercial Technologies. Post-award identification and assertion of restrictions on noncommercial technical data and noncommercial computer software are governed by paragraph (e) of DFARS 252.227-7013 and DFARS 252.227-7014, respectively. The term "source selection decision" in paragraph (e) of DFARS 252.227-7013 and DFARS 252.227-7014 includes Buyer's decision to award this contract based upon the final negotiated agreement (including, but not limited to, the final agreed to terms and conditions and contract price).
 - (ii) Commercial Technologies. Seller may supplement or revise its pre-award identification and assertion of restrictions on commercial computer software and commercial technical data only if such an expansion or revision would be permitted for noncommercial computer software or noncommercial technical data pursuant to paragraph (b)(2)(i) of this clause (i.e., based on new information, or inadvertent omissions that would not have materially affected the final negotiated agreement [including, but not limited to, the final agreed to terms and conditions and contract price]).
 - (iii) Upon request by Buyer, Seller shall provide sufficient information to enable Buyer's customer to evaluate any listed assertions.
- (c) Specific Identification of Technical Data and Computer Software. When identifying and asserting restrictions on technical data and computer software pursuant to paragraph (b) of this clause, Seller shall--
 - (1) Ensure that the technical data and computer software are identified by specific reference to the requirement to deliver or provide that technical data or computer software in the contract, for example, by referencing the associated CLINs, SDRLs, or paragraphs in the statement of work. Regarding any computer software that is rehosted, modified, or developed exclusively or partially at Government expense, the asserted restrictions on the associated data license rights shall specifically address source code, object code, executable code, documentation, software support tools, S/SEE (software/systems engineering environment) documentation, Systems/ Software Requirement Documents, Interface Control Documents, etc., in accordance with Clause H001 of this contract.
 - (2) Include the relevant information for all technical data and computer software that are or may be required to be delivered or otherwise provided under the contract -- including all Option CLINs or other optional or contingent delivery requirements (i.e., presuming that Buyer will exercise the option to require delivery), online or remote access to information, and firmware or other computer software to be embedded in hardware deliverables.(d) Copies of Negotiated, Commercial, and Other Non-Standard Licenses. Seller shall provide copies of all proposed specially negotiated licenses(s), commercial license(s), and any other asserted restrictions other than Government purpose rights; limited rights; restricted rights; SBIR data rights for which the protection period has not expired; or Government's minimum rights as specified in the clause at 252.227-7015.
