CUSTOMER CONTRACT REQUIREMENTS

4. Prime Contract Special Provisions The following prime contract special provisions apply to this purchase order

5652.204-9003 Disclosure of Unclassified Information (2006). a. On September 21, 2001, the Department of Defense designated Headquarters US Special Operations Command (USSOCOM) a sensitive unit, as defined by Title 10 United States Code (USC) Section 552 (10 USC 552). In keeping with this designation, unclassified information related to USSOCOM military technology acquisitions managed by USSOCOM or any of its component commands, will be designated Controlled Unclassified Information (CUI). As such, Seller hereby unequivocally agrees that it shall not release to anyone outside the Seller's organization any unclassified information, regardless of medium (e.g., film, tae, document, Seller's external website, newspaper, magazine, journal, corporate annual report, etc.), pertaining to any part of this contract or any program related to this contract, uless the Contracting Officer, through Buyer, has given prior written approval. Furthermore, any release of information which associates USSOCOM, Special Operation Forces (SOF), or any component command with an acquisition program, contractor or this contrac is prohibited unless specifically authorized by USSOCOM.

b. Request for approval shall identify the specific information to be released, the medium to be used, and the purpose for the release. Seller shall submit the request to Buyer at least 45 days before the propose date for release for approval. No release of any restricted information shall be made without specific written authorization by Buyer.

c. Seller shall inlude a similar requirement in each subcontract under this contract. Subcontractors shall submit request for authorization to release through Buyer to the Contracting Officer.

d. Seller further understands that Title 18 USC Section 701 specifically prohibits the use of the USSOCOM emblem or logo in any medium (e.g., corporate website, marketing brochure, news paper, magazine, etcl) unless authorized in writing by USSOCOM, through Buyer. Forward any request to use the USSOCOM emblem or logo through the Contracting Officer, via Buyer.
