CUSTOMER CONTRACT REQUIREMENTS

The following customer contract requirements apply to this contract to the extent indicated below. If this contract is for the procurement of commercial items under a Government prime contract, as defined in FAR Part 2.101, see Section 3 below.

- **1. FAR Clauses** The following contract clauses are incorporated by reference from the Federal Acquisition Regulation and apply to the extent indicated. In all of the following clauses, "Contractor" and "Offeror" mean Seller.

252.234-7004 Cost and Software Data Reporting System. (NOV 2014). CSDR reporting is required by Seller if this contract exceeds \$50 milliion. The last sentence in paragraph (b) is deleted.

252.237-7010 Prohibition on Interrogation of Detainees by Contractor Personnel (JUN 2013). This clause applies if the contract requires Seller's personnel to interact with detainees in the course of their duties.

252.245-7001 Tagging, Labeling, and Marking Of Government-Furnished Property (FEB 2011). Contractor shall include this clause in all subcontracts under which Seller acquires any serially-managed items.

The rights of the parties shall be as specified in DFARS 252.227-7013 and DFARS 252.227-2014.
