#### CUSTOMER CONTRACT REQUIREMENTS

#### C. ORGANIZATIONAL CONFLICT OF INTEREST

- a. It is understood and agreed that the contractor, under the terms of this contract, or through the performance of the statement of work made a part of this contract, shall report any potential organizationally conflict of interest (OCI), which could service as a basis for excluding the contractor from supplying products or services to the ordering DOD agencies. Further, during the course of this contract, the Contracting Officer (CO) will not knowingly unilaterally direct the contractor to perform work, in contravention of the above understanding. It will be the contract's responsibility to identify any situation in which the potential of an OCI exists. However, if the CO discerns the potential for an OCI prior to or during the execution of any task or amendment thereto, the CO shall notify the contract, and the contractor shall take immediate actions to resolve any potential OCI. For the purposes of this clause, an organizational conflict of interest means that a company is (1) unable or potentially unable to provide objectivity in performing contract work; (2) unable of potentially unable to render impartial assistance or advice to the Government; and /or (3) has an unfair competitive advantage. AN OCI may result what factors create an actual of potential conflict of interest or and instant contract, or when the nature of the work to be performed on the instance contract creates and actual or potential conflict of interest on a future acquisition. In the latter case, the CO may notify the contractor to discuss restrictions on future activities.
- b. An OCI may be caused by a company's activities or relationship. Furthermore, a company is responsible for monitoring potential OCI of its representatives to include its organic resources, team members, and subcontractors.
- c. The contractor may gain access to proprietary information of other companies during contract performance. The Contractors agrees to enter into company-to-company agreements to (1) protect another company's information from unauthorized use or disclosure for as long as it is considered proprietary by the other company and (2) to refrain from using the information for any purpose other than that for which it was furnished. For information purposes, the contractor shall furnish copies of these agreements to the Contracting Officer. These agreements are not intended to protect information which is available to the Government or to the contract from other sources and furnished voluntarily with out restriction.
- d. The contractor agrees to accept and to complete issued delivery orders, provided that no new OCI are created by acceptance of that order. It is the contractor's responsibility to identify and evaluate potential OCI as early as possible. The contractor shall notify the CO or any identified OCI to avoid creating unnecessary delays in contract execution. The contractor shall not contract with Government prime contractors or any subcontractors in such a way as to create an OCI.
- e. The above restrictions shall be included in all subcontracts, teaming arrangements, and other agreements calling for performance of work which is subject to the OCI restrictions identified in this clause, unless excused in writing by the Contracting Officer.
