CUSTOMER CONTRACT REQUIREMENTS

The following customer contract requirements apply to this contract to the extent indicated below. If this contract is for the procurement of commercial items under a Government prime contract, as defined in FAR Part 2.101, see Section 3 below.

1. FAR Clauses The following contract clauses are incorporated by reference from the Federal Acquisition Regulation and apply to the extent indicated. In all of the following clauses, "Contractor" and "Offeror" mean Seller.

The Seller shall indemnify Buyer for any and all losses suffered by the Buyer due to violations of the Act (as set forth in this clause) by Seller or its subcontractors at any tier.

52.203-10 Price or Fee Adjustment for Illegal or Improper Activity (JAN 1997). This clause applies only if this contract exceeds (i) \$100,000 if included in Buyer's customer RFP or customer contract issued before October 1, 2010 or (ii) \$150,000 if included in Buyer's customer RFP issued on or after October 1, 2010, or if the prime contract was issued prior to October 1, 2010 but was amended after October 1, 2010 to increase the Simplified Acquisition Threshold.If the Government reduces Buyer's price or fee for violations of the Act by Seller or its subcontractors at any tier, Buyer may withhold from sums owed Seller the amount of the reduction.

Boeing will identify the cognizant Government PCO at Seller's request. Each subcontractor certification will be retained in the subcontract file of the awarding contractor.

52.203-13 Contractor Code of Business Ethics and Conduct (APR 2010). This clause applies only if this contract is in excess of \$5,000,000 and has a period of performance of more than 120 days.

52.203-14 Display of Hotline Poster(s) (DEC 2007). This clause applies only if this contract is in excess of \$5,000,000 and is not for a commercial item or performed entirely outside the United States. For the purposes of this clause, the United States is defined as the 50 states, the District of Columbia, and outlying areas.

52.204-2 Security Requirements (AUG 1996). Changes clause means the changes clause of this contract. This clause applies only if access to classified material is required.

52.209-6 Protecting the Government's Interest When Subcontracting with Contractors Debarred, Suspended, or Proposed for Debarment (JUL 1995). Seller agrees it is not debarred, suspended or proposed for debarment by the Federal Government. 252.227-7013 Rights In Technical Data -- Noncommercial Items (NOV 1995). This clause applies only if the delivery of data is required for noncommercial items under this contract.

252.227-7013 Rights In Technical Data -- Noncommercial Items Alternate I (JUN 1995). This clause applies only if the delivery of data is required for noncommercial items under this contract.

252.227-7014 Rights In Noncommercial Computer Software And Noncommercial Computer Software Documentation (JUN 1995). This clause applies only if the delivery of noncommercial computer software or noncommercial computer documentation may be originated, developed or delivered under this contract.

252.227-7015 Technical Data -- Commercial Items (NOV 1995). This clause applies only if the delivery of data is required for

commercial items under this contract.

252.227-7016 Rights in Bid or Proposal Information (JUN 1995).

252.227-7017 Identification and Assertion of Use, Release, or Disclosure Restrictions (JUN 1995).

252.227-7019 Validation of Asserted Restrictions - Computer Software (JUN 1995). This clause applies only if computer software may be originated, developed, or delivered under this contract.

252.227-7027 Deferred Ordering of Technical Data or Computer Software (APR 1988). This clause applies only if technical data or computer software may be generated as part of the performance of this contract.

252.227-7030 Technical Data - Withholding of Payment (OCT 1988). In this clause, "Government" and "Contracting Officer" shall mean Buyer. This clause applies only if the delivery of technical data is required under this contract.

252.227-7036 Declaration of Technical Data Conformity (JAN 1997). This clause applies only if the delivery of data is required by this contract.

252.227-7037 Validation of Restrictive Markings on Technical Data (NOV 1995). This clause applies only if the delivery of technical data is required under this contract and the contract is not for commercial items or commercial components.

252.231-7000 Supplemental Cost Principles (DEC 1991).

252.247-7024 Notification of Transportation of Supplies by Sea (NOV 1995). Contracting Officer and, in the first sentence of paragraph (a), Contractor mean Buyer. This clause applies only if the supplies being transported are noncommercial items or commercial items that (i) Seller is reselling or distributing to the Government without adding value (generally, Seller does not add value to items that it contracts for f.o.b. destination shipment); (ii) are shipped in direct support of U.S. military contingency operations, exercises, or forces deployed in humanitarian or peacekeeping operations; or (iii) are commissary or exchange cargoes transported outside the Defense Transportation System in accordance with 10 U.S.C. 2643.

a. For the purpose of this clause "Information" includes, but is not limited to, news release articles, manuscripts, brochures, advertisements, still and motion pictures, speeches, trade association meetings, symposia, etc. Any such information to be disseminated on behalf of the WSTIAC shall bear the distribution statement "Approved for Public Release, Distribution Unlimited."

d. Seller further agrees to include this provision in any second-tier contract award as a result of this contract.

ORGANIZATIONAL CONFLICTS OF INTEREST (DESC 52.209-9E04) (JAN 1992)

By virtue of WSTIAC's comprehensive interaction with DoD planning groups and panels, the Seller may be in a position to obtain and possess information regarding DoD short and long range planning for military applications of weapon systems technologies in advance of industry at large. As a result, the potential for an organizational conflict of interest exists. Accordingly, if the Seller

(a) has received advance procurement information before such information has been made generally available to other persons or firms;

(b) directly assists in the development of the specifications, statement of objectives or statements of work;

(c) is requested to evaluate system requirements, system definitions, or other products developed by the Seller under this contract; or

(d) is requested to construct or fabricate any system, equipment, hardware, and/or software for which the Seller participated in the development of requirements or definitions pursuant to this contract, it shall be excluded during the term of the contract and for two (2) years thereafter from the receipt of any award directly attributable as the result of performance under the

WSTIAC contract. Operation of the WSTIAC will also require access to proprietary data of other companies; therefore, the Seller must agree with such companies to protect such data from unauthorized use or disclosure, so long as it remains proprietary. In addition, unless otherwise expressly agreed to, the Seller will not be permitted to utilize such data in competing for any other acquisition whether formally advertised or negotiated. Within 30 days of identifying the need for a particular company's proprietary data, the Seller shall enter a mutually acceptable protective agreement with that company and furnish the Buyer's Subcontract Administrator a copy of such agreement within 10 days of its execution.

For purposes of this clause "system" means system, subsystem, project or major end item delivered.
