(b) For the purposes of Air Force policy, the following products that are pure (i.e., they meet the relevant product specification identified in AFI 32-7086) are Class I ODSs:

- (1) Halons: 1011, 1202, 1211, 1301, and 2402;
- (2) Chlorofluorocarbons (CFCs): CFC-11, CFC-12, CFC-13, CFC-111, CFC-112, CFC-113, CFC-114, CFC-115, CFC-211, CFC-212, CFC-213, CFC-214, CFC-215, CFC-216, and CFC-217, and the blends R-500, R-501, R-502, and R-503; and
- (3) Carbon Tetrachloride, Methyl Chloroform, and Methyl Bromide.
- (c) The requiring activity has obtained SAO approval to permit the Contractor to use the following Class I ODS(s): None
- (d) The offeror/contractor is required to notify the contracting officer if any Class I ODS that is not specifically listed above is required in the test, operation, or maintenance of any system, subsystem, item, component, or process.

5352.242-9000 Contractor Access to Air Force Installations (NOV 2012). Contracting Officer shall mean Buyer. In paragraph (e) the term "prime contractor" shall mean "Seller" and the term "issuing office" shall mean "Buyer."

5352.242-9001 Common Access Cards (CACs) For Contractor Personnel (AUG 2004). The term contracting officer shall mean Buyer. In paragraph (b) (2), Seller shall submit documentation to Buyer, and Buyer will coordinate with the authorizing official. In paragraph (e), the term issuing office shall mean Buyer.

5. Prime Contract Special Provisions The following prime contract special provisions apply to this purchase order

A. ORGANIZATIONAL CONFLICT OF INTEREST

- a. There is a potential for organizational conflicts of interest (OCIs) under this contract. An OCI will be present when a DS TATs IDIQ prime contractor or subcontractor is also the DTIC Defense Systems Information Analysis Center (DSIAC) Basic Center Operations (BCO) prime contractor responsible for searching and disseminating data from the IAC's repository of STI. The Government is completely mitigating this risk by not allowing a DSIAC BCO prime contractor to also be a prime/subcontractor on a DS TATs IDIQ contract. Another conflict may be present when an DS TATs IDIQ prime contractor or subcontractor is also a subcontractor to the DTIC DSIAC BCO contract. As OCIs are identified in the course of awarding (1) IDIQ contracts under this solicitation, (2) task or delivery orders under any resulting DS TATs IDIQ contract, or (3) contracts to DTIC IAC contractors, the Contracting Officer shall take action to avoid, mitigate, or neutralize such OCI as required under FAR Subpart 9.5. The Contracting Officer's actions may include, without limitation, restraints on the future activities of Seller. The precise details and characteristics of such restraints or other necessary actions shall be determined as specific OCI are identified. The actions to be taken by the Contracting Officer under FAR Subpart 9.5 shall be open to discussion, through Buyer. Nevertheless, after engaging in good faith discussions, the Contracting Officer shall exercise his or her responsibilities under FAR Subpart 9.5 at his or her sole discretion, through Buyer, regardless of whether agreement is reached with Seller.
- b. OCIs may also arise under circumstances outside of the operations of the DTIC. Such OCIs may be identified by the Government, Buyer, or Seller. Seller agrees that if, at any time, Seller identifies a potential or actual OCI, Seller shall make full disclosure in writing to Buyer. This disclosure shall include a description of the OCI and the action(s) Seller has taken, if any, to avoid, mitigate, or neutralize the OCI. Buyer may require Seller to prepare an OCI risk mitigation plan to avoid, mitigate, or neutralize the potential or actual OCI. Whenever an OCI is identified, Buyer shall take action in the same manner described in the paragraph immediately above.
- c. Seller further agrees to insert a provision with substantially the same language as this clause in all subcontracts awarded in relation to DS TATs IDIQ efforts. Any restraints required by the Government or

Buyer shall be imposed in accordance with the provisions of FAR Subpart 9.5, with particular attention to FAR 9.507-2.

B. ACKNOWLEDGEMENT OF SPONSORSHIP

- a. Seller shall comply with DFARS 252.235-7010.
- b. For the purpose of this clause "material" includes, but is not limited to, news release articles, manuscripts, brochures, advertisements, still and motion pictures, speeches, trade association meetings, symposia, etc. Any such information to be disseminated by a DS TATs contractor shall bear the distribution statement Approved for Public Release, Distribution Unlimited.
- c. Seller further agrees to include this provision in any subcontract awarded as a result of this contract.

C. UNAUTHORIZED REPRESENTATION

Seller shall not represent itself as a part or agent of the United States Government, and shall affirmatively and clearly identify itself in all correspondence, including e-mail. Seller shall direct its employees as necessary to ensure compliance with this provision.

D. COMSEC NOTICE

All communications with DoD organizations are subject to communications security (COMSEC) review. Seller personnel shall be aware that telecommunication networks are continually subject to intercept by unfriendly intelligence organizations. The DoD has authorized the military departments to conduct COMSEC monitoring and recording of telephone calls originating from, or terminating at, DoD organizations.

E. CONTRACTOR IDENTIFICATION REQUIREMENTS & PERFORMANCE OF WORK ON GOVERNMENT PREMISES

Seller personnel performing services on Department of Defense installations or other Government facilities shall ensure that they are readily identifiable as Seller employees. Seller shall be required to contact the TAT Government requiring activity to obtain the necessary base entry procedures.

- a. Seller employees shall:
- 1) Identify themselves as Seller personnel at the onset of every telephone call made from a Government telephone or any other phone if the call is made in support of any service provision to the Government;
- 2) Identify themselves as Seller personnel in all recorded messages including those which are heard by callers attempting to contact Seller employees via answering machines or voice mail;
- 3) Identify themselves as Seller personnel at the onset of every meeting, conference or any other gathering attended in support of any service provision to the Government;
- 4) Identify themselves as Seller personnel on any correspondence, documents or reports accomplished or sent in support of any service provision to the Government, including but not limited to, correspondence sent via the U.S. Mail, facsimile or electronic mail (email) inclusive of "out-of-office" replies;
- 5) Wear or display Seller provided nametags, badges or attire which display, at a minimum, the name of Seller.
- b. Any work under this contract which is performed by Seller or any of its subcontractors on premises under Government control is subject to all requirements of this contract governing such work, and the following:
- 1) All Seller and subcontractor personnel shall, at all times, conspicuously display a distinctive badge provided by Seller, identifying such personnel as employees of Seller and shall observe and otherwise be subject to such security regulations as are in effect for the particular premises involved.
- 2) All Seller and subcontractor personnel shall be easily recognized by wearing Government provided security badges while working in a U.S. Government facility.
- 3) Seller shall provide direct supervision of its own employees but shall not supervise or accept supervision from any Government personnel.
- 4) Seller shall designate in writing, an on-the-premises representative to serve as point of contact for the Seller to Buyer or their duly authorized representative.
- 5) All Seller and subcontractor employees shall dress appropriately for a professional work environment.
