### QUALITY MANAGEMENT SYSTEM REQUIREMENTS FOR DISTRIBUTOR OR MANUFACTURER OF STANDARD PARTS AND RAW MATERIAL

Seller is required to maintain a quality management system in conformance with requirements specified below.

Requirements below which identify Buyer's document D6-82479, "Boeing Quality Management System Requirements for Suppliers" are supplemented with requirements for Boeing Recognition of Aviation, Space and Defense Quality Management System Accredited Certification/Registration of the D6-82479 document as each may be amended from time to time. Such document, specified Appendix and recognition requirements are incorporated herein and made a part hereof by this reference. A copy of Buyer's document D6-82479, including all appendices and recognition requirements can be obtained at the following URL address:

1. When Seller is a distributor carrying out the purchase, storage, splitting or sale of goods without affecting the original manufacturer's product characteristics or conformity, Seller shall conform to Buyer's document D6-82479, "Boeing Quality Management System Requirements for Suppliers" Appendix D, "Quality Management Systems - Requirements for Aviation, Space and Defense Distributors".

Note: Appendix A, "Quality Management Systems – Requirements for Aviation, Space and Defense Organizations" is an acceptable alternative to Appendix D.

2. When Seller is a distributor performing or outsourcing manufacturing/fabrication, product installation, servicing, additional inspection or test, physical re-identification, product assembly, and/or kitting processes, Seller shall conform to Buyer's document D6-82479, "Boeing Quality Management System Requirements for Suppliers" Appendix A, "Quality Management Systems – Requirements for Aviation, Space and Defense Organizations".
3. When Seller is the original manufacturer of goods described below, Seller shall maintain a quality system that will ensure all goods and services conform to contract requirements.
  - Standard items where design criteria are not modified by Boeing [e.g., commercial off the shelf items common to the industry and available in the same form to the public without modification, military, industry and federal standard parts, software, Qualified Parts List (QPL) items, labels, decals, stencils, paint, tape, yarn, etc.].
  - Boeing standard parts and D-590 controlled items other than designated fasteners (nuts, bolts, screws, collars or rivets) and aircraft bearings.
  - Raw material where design criteria are not modified by Boeing (e.g., pre-impregnated fabric, honeycomb core).

Buyer reserves the right to conduct surveillance at Seller's facility to make final determination that Seller's quality management system conforms to requirements as set forth herein.
