It does not include any modification, realignment, or redirection of Contractor efforts under this contract; such action may be effected only by the prior written direction of the Procuringn Contracting Officer.
- (2) The purpose of the review isto:
- (i) Evaluate from a technical standpoint whether system concept and performance can be expected to bachieved on schedule and within cost.
- (ii) Assure that the impact of new data new developments and modified requirements is properly assessed and exploited
- (iii) Assure that The MITRECorporation has available data on the status and technology of Government programs and projects to enable it to carry out its inter-system integration responsibilities to the Government.
