CUSTOMER CONTRACT REQUIREMENTS

The following customer contract requirements apply to this Contract to the extent indicated below. If this Contract is for the procurement of commercial products and/or commercial services under a Government prime contract, as defined in FAR Part 2.101, Section 3 replaces the requirements of Sections 1 and 2 below. Please note, the requirements below are developed in accordance with Buyer's prime contract and are not modified by Buyer for each individual Seller or statement of work. Seller will remain at all times responsible for providing to any government agency, Buyer, or Buyer's customer, evidence of compliance with the requirements herein or that such requirements are not applicable to the extent satisfactory to the requesting party.

- **1. FAR Clauses** The following contract clauses are incorporated by reference from the Federal Acquisition Regulation and apply to the extent indicated. In all of the following clauses, "Contractor" and "Offeror" mean Seller.

 - **52.203-12** Limitation on Payments to Influence Certain Federal Transactions (JUN 2020). Paragraph (g)(2) is modified to read as follows: "(g)(2) Seller will promptly submit any disclosure required (with written notice to Boeing) directly to the PCO for the prime contract. Boeing will identify the cognizant Government PCO at Seller's request. Each subcontractor certification will be retained in the subcontract file of the awarding contractor."

Delete paragraph (f) and insert the following paragraph (f) in lieu thereof: "Seller shall make the representation required by paragraphs (b) and (c) of this clause by submitting an updated Buyer Form F70102 or updating Seller's profile information on line in Buyer's SPVR system."
- **52.222-1 Notice to the Government of Labor Disputes** (FEB 1997). The terms "Contracting Officer" shall mean Buyer.
- **52.222-19** Child Labor Cooperation with Authorities and Remedies (JAN 2025). In paragraph (b), the term "solicitation" refers to the prime solicitation. In paragraph (d), "Contracting Officer" means Buyer.

The Buyer will process VECP's expeditiously; however, it will not be liable for any delay in acting upon a VECP. Paragraph (m) shall read as follows: (m) Data. The Seller may restrict the Government's right to use any part of a VECP or the supporting data by marking the following legend on the affected parts: These data, furnished under the Value Engineering clause of contract, shall not be disclosed outside the Buyer and Government or duplicated, used, or disclosed, in whole or in part, for any purpose other than to evaluate a value engineering change proposal submitted under the clause. This restriction does not limit the Buyer's and Government's right to use information contained in these data if it has been obtained or is otherwise available from the Seller or from another source without limitations. If a VECP is accepted, the Seller hereby grants the Government unlimited rights in the VECP and supporting data, except that, with respect to data qualifying and submitted as limited rights or Government purpose rights technical data, the Government shall have the rights specified in the contract modification implementing the VECP and Seller shall appropriately mark the data. (The terms "unlimited rights" a "limited rights" and "Government purpose rights" are defined in Part 27 of the Federal Acquisition Regulation ("FAR") or Part 227 of the Defense FAR Supplement, as applicable.) Seller's share of the net acquisition savings and collateral savings shall not reduce the Government's share of concurrent or future savings or collateral savings. Buyer's payments to Seller under this clause are conditioned upon Buyer's receipt of authorization for such payments from the Government
- **52.251-1 Government Supply Sources** (APR 2012). This clause applies only if Seller is notified by Buyer in writing that Seller is authorized to purchase from Government supply sources in the performance of this contract.
- **52.246-23 Limitation of Liability** (FEB 1997). The term Contractor means Seller.
- **2. DoD FAR Supplement Clauses** DoD Contracts. In paragraph (e), the remedies described in subparagraphs (2) and (3) are available to Buyer, not the Government. In paragraph (f), "through the Buyer" is inserted after "Contracting Officer." Paragraph (g) is deleted.

252.204-7009 Limitations on the Use or Disclosure of Third-Party Contractor Reported Cyber **Incident Information** (JAN 2023). This clause applies to contracts for services that include support for the Government's activities related to safeguarding covered defense information and cyber incident reporting, including contracts for commercial products and commercial services.

252.204-7012 Safeguarding Covered Defense Information and Cyber Incident Reporting Deviation (MAY 2024).

This clause applies if the Contract is for operationally critical support or where performance will involve a covered contractor information system. The term "contractor" retains its original meaning wherever the word is not capitalized. In the terms "Contractor attributional/proprietary information," "Contractor information system" and "covered contractor information system," the term "contractor" also retains its original meaning. In paragraphs (d) and (g), "Contracting Officer" shall mean "Contracting Officer or Buyer." In paragraph (m)(2), the term "prime Contractor" retains its original meaning. In accordance with paragraph (m)(2)(i), Seller shall notify Buyer when submitting a request to the Contracting Officer to vary from NIST SP 800-171. Seller represents and warrants that (i) it is in compliance with the requirements of DFARS Clause 252.204-7012 (DEVIATION 2024-O0013) as modified by the preceding paragraph, or (ii) that, pursuant to paragraph (b)(2)(ii)(B), it has submitted a request applicable to this Contract for a variance from the requirements of NIST SP 800-171, to the US Government Contracting Office and that Seller's request for such variance was approved by an authorized representative of the DoD CIO.

252.204-7018 Prohibition on the Acquisition of Covered Defense Telecommunications Equipment or Services (JAN 2023). In paragraph (d), all required reporting shall be to Buyer.

- **252.222-7006 Restrictions on the Use of Mandatory Arbitration Agreements** (JAN 2023). This clause applies to all solicitations and contracts (including task or delivery orders and bilateral modifications adding new work) valued in excess of \$1 million, except for contracts for the acquisition of commercial products or commercial services, including commercially available off-the-shelf-items. This clause applies to contracts at any tier that exceed the simplified acquisition threshold, as defined in Federal Acquisition Regulation 2.101 on the date of contract award, and are for services, including construction, performed in whole or in part within the United States or its outlying areas.

252.225-7001 Buy American and Balance of Payments Program (DEC 2017). In paragraph (c), the phrase "in the Buy American Balance of Payments Program Certificate provision of the solicitation" is deleted and the word "certified" is deleted and replaced with the word "specified."

252.225-7009 Restriction on Acquisition of Certain Articles Containing Specialty Metals (DEC 2019).

252.227-7013 Rights In Technical Data -- Noncommercial Items (FEB 2014). This clause applies when technical data for noncommercial items, or for commercial items developed in any part at

- 252.227-7037 Validation of Restrictive Markings on Technical Data (SEP 2016).
- **252.228-7001 Ground and Flight Risk** (MAR 2023). This clause does not apply to contracts with Federal Aviation Administration (FAA) part 145 repair stations performing work pursuant to their FAA license.

- (a) Contractor personnel assigned to perform work under this contract may require access to Navy Information Technology (IT) resources (e.g., computers, laptops, personal electronic devices/personal digital assistants (PEDs/PDAs), NMCI, RDT&E networks, websites such as MyNAVAIR, and Navy Web servers requiring Common Access Card (CAC) Public Key Infrastructure (PKI)). Contractor personnel (prime, subcontractor, consultants, and temporary employees) requiring access to Navy IT resources (including those personnel who previously signed SAAR DD Form 2875) shall submit a completed System Authorization Access Request Navy (SAAR-N), OPNAV 5239/14 (Jul 2008) form or latest version thereof, and have initiated the requisite background investigation (or provide proof of a current background investigation) prior to accessing any Navy IT resources. - (b) SAAR-N forms will be submitted to the Government Sponsor or Technical Point of Contact (TPOC) via the contractor's Facility Security Officer (FSO). The designated SAAR-N Government Sponsor or TPCO for contractor employees requiring IT access, [fill-in name] shall be responsible for signing and processing the SAAR-N forms. For those contractors that do not have a FSO, SAAR-N forms shall be submitted directly to the designated SAAR-N Government Sponsor or TPOC. Copies of the approved SAAR-N forms may be obtained through the designated SAAR-N Government Sponsor or TPOC. Requests for access should be routed through the NAVAIR_SAAR.fct@navy.mil mailbox.
- (c) In order to maintain access to Navy IT resources, the contractor shall ensure completion of initial and annual IA training, monitor expiration of requisite background investigations, and initiate reinvestigations as required. For those contractor personnel not in compliance with the requirements of this clause, access to Navy IT resources will be denied/revoked.

5. Prime Contract Special Provisions The following prime contract special provisions apply to this purchase order

H-2 Special Provision . TECHNICAL DATA AND SOFTWARE NECESSARY FOR THE GOVERNMENT TO OPERATE, MAINTAIN, REPAIR, AND ENSURE THE SAFETY, AIRWORTHINESS, AND RELIABILITY OF THE MQ-25 AIR SYSTEM

A. Intent of the parties for the MQ-25 program is that,

- (1) the Contractor will provide to the Government, either through current or future contract delivery or pursuant to a Special License Agreement as attached hereto, all technical data and software within its control (meaning either Contractor owned or, if supplier owned, the contractor has the right to sublicense such technical data or software to the Government) that Contractor developed under or utilized for the MQ-25 program and that is necessary for the Government to operate, maintain (including development of sustainment documentation), repair, both ashore and afloat, in a connected and disconnected environment, the MQ-25 Air System for continued safety, airworthiness, and reliability in accordance with COMNAVAIRFORINST 13034 and COMNAVAIRINST 4790.2.
- (2) for deliverables,
- (a) the technical data and software delivered, per Section F and/or the enumerated CDRLs, shall be the data or software to allow the Government to perform Organizational level (O-Level) Maintenance, Intermediate level (I-Level) Maintenance, and Depot level (D-Level) Maintenance as defined in the COMNAVAIRFORINST 4790.2 series and other sustainment activities. The data and software to be delivered shall include no less information or detail than the Contractor requires to perform sustainment activities.
- (b) the Contractor shall maximize use of publicly accessible DoD or Industry standards and/or specifications for these deliverables. All non-public standards and/or specifications shall either be delivered or provided to the Government via the MQ-25 Special License Agreement attached hereto.

B. Process

In the event the Government and the Contractor do not agree as to if or how a particular technical data or computer software element shall be provided, the parties agree that the Government and Contractor shall immediately negotiate whether the element should be delivered or categorized pursuant to the current MQ-25 Special License Agreement. Further, should the parties discover an element that has not been provided as a deliverable or categorized under the SLA, the parties shall immediately negotiate whether the element should be delivered, or categorized pursuant to the current MQ-25 Special License Agreement (the "Resolution Process").

As part of the Resolution Process, the Contractor shall make the technical data or computer software element available to select Government personnel pursuant to terms and protections of sub-paragraph D of this clause.

If not delivered and is required in order to meet the intent of the parties as set forth in accordance with paragraph A, the element shall either (1) be categorized and added to the SLA or (2) the Government will continue to have access to the item pursuant to sub-paragraph D of this clause until the Government has exhausted any and all available remedies in accordance with the DFARS related to delivery of the element in dispute.

The Contractor shall include the pertinent portions of this clause in Requests for Proposals (RFPs) to its subcontractors as it aligns to the intent of paragraph A. The Contractor shall notify the Procurement Contracting Officer within 20 business days if any subcontractor or supplier at any tier notifies the Contractor it is unwilling to include this clause in a resulting subcontract or other contractual or legal instrument. Thereafter the parties will actively work to resolve the issue, including where appropriate, involving the Government in conversations with the supplier, and which could result in direct licensing of data from a subcontractor to the Government.

C. Delivery Requirements for this Contract

- (1) The Contractor shall deliver the technical data package (TDP) and software required by the Statement of Work, Section F and/or the applicable CDRL, XXXX. The design data and software design to be delivered shall include no less information or detail than the Contractor requires to perform sustainment activities.
- (2) As identified in the CDRL the Contractor shall maximize use of publicly accessible DoD or Industry standards and/or specifications. All non-public standards and/or specifications shall either be delivered or provided to the Government via the MQ-25 Special License Agreement attached hereto.
- D. Protections for Technical Data and Computer Software Elements Made Available Under the Resolution Process
- (1). DEFINITIONS. "Resolution Process Proprietary Information" (RPPI) is all Contractor owned and third party information disclosed by Contractor and all Contractor-owned information, regardless of form, that is furnished or made available to the Government pursuant to the Resolution Process of this H-clause. RPPI includes, for example, technical data, computer software, and processes. RPPI shall be subject to this Agreement as of the date of its receipt by the Government.
- (2). PURPOSE. The Government may use RPPI solely to determine whether the RPPI shall be delivered under the Contract or categorized and added to the SLA.
- (3). RESTRICTIONS. The Government shall safeguard Contractor RPPI to protect it against theft, loss, unauthorized disclosure, misappropriation or misuse. The Government will limit access to RPPI it receives to employees who have a "need to know" the RPPI in connection with the Purpose, and, except as set forth below, shall not disclose RPPI to any third party without written authorization from Contractor. The Government may disclose received RPPI within the Government during the term of this Agreement solely as required for the Purpose. The Government may transmit received RPPI only by using an encryption method substantially similar to that under which it was received. The Government will not use RPPI received under this Agreement for design or manufacture. The Government agrees not to reverse engineer, decompile or disassemble any RPPI received under this Agreement. Notwithstanding the foregoing, nothing in this Agreement shall be interpreted to restrict lawfully reporting waste, fraud, or abuse to a designated Government representative authorized to receive such information.
- (4). STANDARD OF CARE. The Government shall exercise reasonable care in satisfying its obligations to protect RPPI.
- (5). NO LICENSE. No disclosure or physical transfer of RPPI under this Agreement will be construed as granting (a) a license under any patent, patent application or copyright, or (b) any right of ownership in such Proprietary Information.
- (6). TERM. Unless earlier terminated by mutual agreement of both parties, the permissions granted under this clause shall terminate on completion of the Resolution Process. Any such expiration or termination will have no effect upon the Government's obligations relative to RPPI disclosed hereunder prior to the effective date of expiration or termination.
- (7). RETURN/DESTROY. Upon completion of the Resolution Process, the Government will make best efforts to destroy, as applicable, and to ensure all recipients destroy any RPPI including all copies, provided hereunder, and to destroy, as applicable, any documents derived, made or compiled from RPPI, and will confirm such destruction in writing to Contractor within thirty (30) calendar days of the effective date of completion of the Resolution Process.

H-4 Special Provision . COMMERCIAL COMPUTER SOFTWARE LICENSE AGREEMENT

- (a) Reserved.
- (b) Open source software (OSS). OSS is generally regarded as commercial computer software. It is sometimes licensed under terms that require the user to make freely available in source code form: (i) the user's modifications to the OSS or (ii) any software that the user "combines" with the OSS. If the Seller uses OSS in the performance of this contract, the Seller must ensure that the use of the OSS

complies with subsection (c) of this clause.

(c) Commercial Computer Software. The Seller shall acquire the commercial computer software under the licenses customarily provided to the public, except to the extent that the licenses are inconsistent with Federal procurement law or do not otherwise satisfy user needs (see DFARS 227.7202-1(a)). A list of common material terms and conditions of commercial computer software license agreements NAVAIR has determined are inconsistent with Federal procurement law or do not otherwise satisfy user needs are incorporated into an addendum that may be executed by the Seller when negotiating the license agreements to be delivered to the Government. The Seller shall either execute an addendum to the license being delivered or shall ensure that the license being delivered to the Buyer complies with the contract's required terms and conditions prior to delivering the licensed software.

The Seller shall provide copies of the license agreements within 90 calendar days of license purchase or at least 90 calendar days prior to delivery, whichever occurs first.

H-5 Special Provision . NONCOMMERCIAL OPERATIONAL FLIGHT PROGRAM SOFTWARE

- (a) Operational Flight Program (OFP) software is defined as all Air Vehicle (AV) noncommercial computer software and noncommercial computer software documentation that performs the functions and sub-functions necessary for MQ-25 AV operations inclusive of all stores, payloads, avionics, and communications equipment controls. The OFP does not include inputting systems/subsystems software, e.g. the Full Authority Digital Engine Controller (FADEC), Embedded Global Positioning Systems Inertial (EGIs), Electro-Optical/Infrared (EO/IR), etc. Reference DFARS 252.227-7014 for the definitions of "noncommercial computer software" and "noncommercial computer software documentation."
- (b) To support the Government's sustainment and cost strategies, all OFP Software shall be delivered only in the following:
 - (1) In a development environment that the Government developed or already owns; or
 - (2) In a development environment that is considered to be commercially available off the shelf (COTS) in accordance with FAR 2.101 and in compliance with Clause H-4 (Commercial Computer Software); or
 - (3) In a development environment that is developed by the Seller to which the Seller controls the licensing and hereby agrees to provide to the United States Department of Defense (DoD), in perpetuity, rights consistent with "Government Purpose Rights" (as defined in DFARS 252.227-7013 or DFARS 252.227-7014).

The development environment shall provide the DoD and DoD sellers (with a legitimate Government purpose) an equivalent ability as that of the Seller to operate and use the development environment. The development environment shall be provided in a media enabling independent Government installation and upgrades to new and existing pre-configured systems and shall include all associated computer software documentation. The development environment shall include a full set of processes and programming tools needed to create the OFP software product and enable the Government to use, modify, display, manipulate, reconfigure, recompile, and reproduce the OFP Software. The price of all licenses related to (b)(3) above shall be included in the price. Copies of the license shall be provided for incorporation into the contract as. Any changes to the software programs identified from the time of award shall be submitted to the Government for approval.

(c) OFP Special License Rights.

The Seller hereby agrees that previously obtained rights shall continue to apply, without modification, with regard to OFP software, interfaces, and associated technical data, which were delivered to the Government with the special negotiated license rights set forth in support of prime Contract N00019-18-C-1012. The original expiration date established for the DOD restrictions in accordance with this license (30 August 2028) shall remain unchanged.

- (d) Subcontractors and Suppliers. The Seller shall include this clause in its subcontracts or other contractual or legal instruments with its subcontractors or suppliers at any tier.
- (e)Deferred Ordering. The terms and conditions of this clause shall apply to any technical data and/or noncommercial computer software delivered under this contract pursuant to DFARS 252.227-7027

H-6 Special Provision . DATA RIGHTS AND LICENSES IN SUPPORT OF TEST ACTIVITIES

(a) Verification Data, as used in this clause, is defined as Test Data and data gathered/collected in support of demonstration, analysis, similarity, inspection, and evaluation verification methods. Test

Data, as used in this clause, is defined as any noncommercial Air System Level test unique processed or unprocessed on-board or off-board system data collected or processed in support of Modeling and Simulation, laboratory integration and test activities, installed systems ground and flight test evolutions, and test reporting. All Test Data shall be delivered in the form(s) in which the information is ordinarily maintained as true native files, meaning that metadata is intact enabling the Government the same ability as the Contractor to use, modify, reproduce, release, perform, display, or disclose the information. Metadata includes computer data such as date/created/modified/author and the hidden material that does not appear when a document is printed (e.g. hidden rows, cells and formulas, track changes, etc.).

- (b) All Verification Data produced for this contract is an element of performance per DFARS 252.227-7013(b)(1)(ii) and shall be provided with unlimited rights. Any Verification Data that was not produced for this contract and/or any non-Verification Data that is delivered concurrently with the Verification Data shall be segregated as a separate annex or attachment to the Verification Data produced for this contract unless the license is Unlimited or Government Purpose Rights.
- (c) The Seller shall deliver all Verification Data collected to support requirements verification pursuant to the requested Verification Cross Reference Matrix.
- (d) The Seller shall maximize the use of Government and non-proprietary tools. All Verification Data shall be collected and delivered to the Government using only:
 - (1) a tool the Government developed or already owns;
 - (2) a tool considered to be commercially available off the shelf (COTS) in accordance with FAR 2.101 and in compliance with Clause H-4 (Commercial Computer Software); or
 - (3) a tool or plugin developed by the Seller to which the Seller controls the licensing and hereby agrees to provide to the United States Department of Defense (DoD), in perpetuity, rights consistent with "Government Purpose Rights" (as defined in DFARS 252.227-7013 or DFARS 252.227-7014).

These tools shall provide the DoD and DoD sellers (with a legitimate Government purpose) an equivalent ability as that of the Seller to operate and use these tools. These tools shall be provided in a media enabling independent Government installation and upgrades to new and existing pre-configured systems and shall include all associated computer software documentation. The licenses shall allow the Government the right to use, modify, display, manipulate, reproduce, and reinterpret the Verification Data. The price of all licenses related to (b)(3) above shall be included in the price. Copies of the license shall be provided for incorporation into the contract. Any changes to the software programs identified from the time of award shall be submitted to the Government for approval.

- (e) Prior Government Rights Established for Verification Data
 (1)The Seller hereby agrees that previously obtained rights shall continue to apply, without modification, with regard to verification data in support of test activities which were delivered to the Government with the special negotiated license rights set forth in support of prime contract N00019-18-C-1012. The original expiration date established for the DOD restrictions in accordance with this license (30 August 2028) shall remain unchanged.
- (f) Subcontractors and Suppliers. The Seller shall include this clause in its subcontracts or other contractual or legal instruments with its subcontractors or suppliers at any tier.
- (g) Deferred Ordering. The terms and conditions of this clause shall apply to any technical data and/or noncommercial computer software delivered under this contract pursuant to DFARS 252.227-7027.

H-7 Special Provision . RIGHT TO OBTAIN INTELLECTUAL PROPERTY, EQUIPMENT, AND ASSOCIATED LICENSE RIGHTS

- (a) This clause provides the Government with the notification described in paragraph (c) concerning the assignment or change of control regarding Subject Intellectual Property (IP) and/or Equipment (as defined below). It is understood by both parties that this is a notification requirement only and shall not prevent any assignment or change of control from occurring.
- (b) Definitions. The following terms are defined for the purpose of this clause:
 - (1) Subject IP means any technical data and/or computer software developed exclusively at private expense provided or available under any delivery requirement under the contract.
 - (2) Equipment means unique manufacturing processes and equipment associated with the Subject IP offered for sale or subject to transfer.

(c) The Seller shall transmit to the Government a notice of any of the following events:

- a. A notice of the Seller's decision to pursue the transfer of ownership or control of Subject IP and/or Equipment or any part thereof to a third party;
- b. A notice received from the Seller by a subcontractor of an intention to pursue the transfer of ownership or control of Subject IP and/or Equipment or any part thereof to a third party;
- A notice concerning the filing of any judicial proceeding not subject to paragraph (c)(4) below that may result in the Seller's or a subcontractor's transfer or loss of ownership or control of the Subject IP and/or Equipment or any part thereof;
- d. A notice concerning the voluntary or involuntary sale in a bankruptcy, insolvency, or receivership proceeding where the debtor solicits for sale any or all of its assets that would include the Subject IP and/or Equipment or any part thereof;
- e. A notice concerning the receipt of an unsolicited offer to purchase the Subject IP and/or Equipment or any part thereof that the Seller or subcontractor intends to pursue;
- f. A notice concerning a voluntary or involuntary transfer of the Seller's or subcontractor's Subject IP and/or Equipment or any part thereof pursuant to a security interest.
- (d) The Seller shall provide the notice within 30 days of the event described in paragraph (c). The notice shall describe the Subject IP and/or Equipment and identify the Seller and the Buying/Receiving entity.
- (e) The Seller and/or subcontractor are requested to contact the Navy Procuring Contracting Officer directly prior to the sale of the Subject IP and/or Equipment to discuss a sale to the Government.
- (f) The Seller shall include this clause in its subcontracts or other contractual or legal instruments with its subcontractors or suppliers at any tier.
