Seller shall establish and maintain systems and procedures necessary to provide a program of foreign object damage/control.

B. NOTIFICATION OF DEBARMENT/SUSPENSION STATUS

Seller shall provide immediate notice to Buyer in the event of being debarred suspended, or proposed for debarment by any Federal Agency during the performance of this Contract.

C. HEALTH AND SAFETY ON GOVERNMENT INSTALLATIONS (JUN 1997)

- (1) In performing work under this contract on a Government installation, the contractor shall:
 - (a) Comply with the specific health and safety requirements established by this contract;
 - (b) Comply with the health and safety rules of the Government installation that concern related activities not directly addressed in this contract;
 - (c) Take all reasonable steps and precautions to prevent accidents and preserve the health and safety of contractor and Government personnel performing or in any way coming in contact with the performance of this contract; and
 - (d) Take such additional immediate precautions as the contracting officer may reasonably require for health and safety purposes.
- (2) The contracting officer may, by written order, direct Air Force Occupational Safety and Health (AFOSH) Standards and/or health/safety standards as may be required in the performance of this contract and any adjustments resulting from such direction will be in accordance with the Changes clause of this contract.
- (3) Any violation of these health and safety rules and requirements, unless promptly corrected as directed by the contracting officer, shall be grounds for termination of this contract in accordance with the Default clause of this contract.

D. SELLER ACCESS TO AIR FORCE INSTALLATIONS (JUN 2002)

- (1) The Seller shall obtain base identification and vehicle passes for all Seller personnel who make frequent visits to or perform work on the Air Force installation(s) cited in the contract. Seller personnel are required to wear or prominently display installation identification badges or Seller-furnished, Seller identification badges while visiting or performing work on the installation.
- (2) The Seller shall submit a written request on company letterhead to the Buyer listing the following: contract number, location of work site, start and stop dates, and names of employees and subcontractor employees needing access to the base. The letter will also specify the individual(s) authorized to sign for a request for base identification credentials or vehicle passes. The Buyer will endorse the request and forward it to the contracting officer for processing. When reporting to the registration office, the authorized Seller individual(s) should provide a valid driver's license, current vehicle registration, valid vehicle insurance certificate, and any additional local base requirements to obtain a vehicle pass.
- (3) During performance of the contract, the Seller shall be responsible for obtaining required identification for newly assigned personnel and for prompt return of credentials and vehicle passes for any employee who no longer requires access to the work site.
- (4) When work under this contract requires unescorted entry to controlled or restricted areas, the Seller shall comply with AFI 31-101, Volume 1, The Air Force Installation Security Program, and AFI 31-501, Personnel Security Program Management, as applicable.

- (5) Upon completion or termination of the contract or expiration of the identification passes, the prime Seller shall ensure that all base identification passes issued to employees and subcontractor employees are returned to the issuing office.
- (6) Failure to comply with these requirements may result in withholding of final payment.

E. COMMON ACCESS CARDS (CACs) FOR CONTRACTOR PERSONNEL (AUG 2004)

- (1) For installation(s)/location(s) cited in the contract, Seller shall ensure Common Access Cards (CACs) are obtained by all Seller or subcontract personnel who meet one or both of the following criteria:
 - (a) Require logical access to Department of Defense computer networks and systems in either:
 - (i) the unclassified environment; or
 - (ii) the classified environment where authorized by governing security directives.
 - (b) Perform work which requires the use of a CAC for installation entry control or physical access to facilities and buildings.
- (2) Seller and their personnel shall use the following procedures to obtain CACs:
 - (a) Seller shall provide a listing of personnel authorized a CAC to the Buyer. The Buyer will provide a copy of the listing to the government representative in the local organization designated to authorize issuance of Seller CACs (i.e., "authorizing official").
 - (b) Seller personnel on the listing shall each complete and submit a DD Form 1172-2 or other authorized DoD electronic form to the authorizing official. The authorizing official will verify the applicant's name against the Seller's listing and return the DD Form 1172-2 to the Seller personnel.
 - (c) Seller personnel will proceed to the nearest CAC issuance workstation (usually the local Military Personnel Flight (MPF) with the DD Form 1172-2 and appropriate documentation to support their identification and/or citizenship. The CAC issuance workstation will then issue the CAC.
- (3) While visiting or performing work on installation(s)/location(s), Seller personnel shall wear or prominently display the CAC as required by the governing local policy.
- (4) During the performance period of the contract, the Seller shall:
 - (a) Within 7 working days of any changes to the listing of the contract personnel authorized a CAC, provide an updated listing to the Buyer who will provide the updated listing to the authorizing official;
 - (b) Return CACs in accordance with local policy/directives within 7 working days of a change in status for Seller personnel who no longer require logical or physical access;
 - (c) Return CACs in accordance with local policy/directives within 7 working days following a CACs expiration date; and
 - (d) Report lost or stolen CACs in accordance with local policy/directives.
- (5) Within 7 working days following completion/termination of the contract, the Seller shall return all CACs issued to their personnel to the issuing office or the location specified by local policy/directives.
- (6) Failure to comply with these requirements may result in withholding of final payment.

F. WARRANTY

Delete the Article set forth in the General Terms and Conditions/General Provisions entitled "Warranty", and insert in lieu thereof the following:

"All Seller and its lower tier subcontractor's warranties, if any, shall inure to and be passed on to the Government. The Seller shall perform all work hereunder in workmanlike manner. A twelve month warranty applies to all Seller newly developed equipment and software from the date of successful completion of first article demonstration of the APU repair capability at Ogden ALC. The Seller shall, when requested by the Government, determine if a returned part is under warranty. In the event that a failed part is under warranty, the Seller shall notify Buyer and the Government of such fact."
